Everyone in the village of Aerok, Ailinglaplap wore a proud smile last month as 10 young ladies graduated from a four-month University of the South Pacific Master Weavers' Apprenticeship program.

During the ceremony, master weaver Terse Timothy thanked all the Ailinglaplap Iroij, the local government, and the University for supporting the program, which saw the youth each create at least one 'jaki-ed' (clothing mat). Acting Mayor Juda Menwe also praised the program, according to master weaver Susan Jieta (pictured) who flew to Aerok for the ceremony.

"I was very impressed with the quality of the students' work," Susan said. "Almost all of the apprentices had made or will have made two mats for the auction in September." This will be held on Friday September 27 at the Marshall Islands Resort and will be the sixth annual auction and sale of jaki-ed, which is a program masterminded by USP

While the official part of the National Training Council-funded program has finished, Susan reported that the women, who live in both Aerok and nearby Jabwon village, will continue to weave at Terse's house. "That's where the weaving circle will stay," she said, adding with a laugh: "Terse told me her house now belongs to USP!"
